FUZZY FERRET RESCUE ADOPTION AGREEMENT

(Fuzzy Ferret Rescue = FFR)

- The ferret(s) will be handled in a loving, gentle manner by all members of my household and by any guests that visit the home. Initial: _____
- The ferret(s) will be fed quality dry ferret food (from the approved food list that has been given to me at the adoption on the date listed above), have access to a **fresh bowl** of water, will be kept indoors & will be housed in a ferret-proof room. Initial: _____
- The ferret(s) will **NOT** be caged for more than **12 hours** per every 24-hour period. Initial: _____ Also, if adopters are unable to spend quality time (8-10 hours per day) with the ferret, unable to keep them as pets, abuse or mistreat the ferret(s), or need to give them up for any other reason, the ferret(s) will be **RETURNED TO FFR. NO EXCEPTIONS!** Initial: _____
- FFR offers annual clinic wellness checks on ALL ferrets; however, if you choose to see another clinic, you agree to send the rescue a copy of those records. Initial: _____
- If the ferret's health is ever in question, the adopter will **CALL FFR** immediately or seek veterinary advice. Initial: _____
- I understand that "Fuzzy Ferret Rescue" retains the right to periodically check on ALL adopted ferrets' wellbeing & living conditions. Initial: _____
- Be it known; adoption fees are considered to be a donation! Those monies go towards paying for food, supplies, medical attention and etc. No profit is ever accrued from these fees & can NOT be refunded. All ferrets leaving the rescue, have been clinically examined, up to date on all distemper vaccinations & are rabies free. NOTE: In the event, the adopted ferret becomes ill, due to natural cause or disease within 7 days of adoption & with CONFIRMATION by a licensed veterinarian (with ferret knowledge & can document - that said illness is of natural occurrence & not from neglect, abuse, living conditions, inflicted injury, or other inhumane acts while in custody of new owners & their domain, a FULL refund will be given.
- FFR also retains the right to "rescue" the ferret, back from its adoptive owners, if it is in any way - abused, neglected, ill or sickly (without seeking clinical advice), in poor living conditions, cage bound, injured by other household pets or humans, or is left or kept outdoors. **No Refund will be given.** When & if this transpires, we will be accompanied by a representative of: Tennessee Department of Agriculture (TDA), ASPCA / Humane Society / Animal Control, local law enforcement official. **WE DO NOT ALLOW ANY KIND OF ANIMAL NEGLECT OR ABUSE!** Initial: _____
